

## Registration Terms for Telia Digital Hub 2025

Telia Digital Hub is organized by Telia Eesti AS and the Ministry of Justice and Digital Affairs. By acquiring a ticket to Telia Digital Hub, you agree to the registration terms.

Telia Eesti AS reserves the right to change the registration terms. Any changes will be published on Telia's website.

### Registration

Registration is open until November 6, 2025, or until all spots are filled. If spots are full, participation is possible via online broadcast. You can modify or cancel your registration until October 30, 2025, by emailing [support@confent.com](mailto:support@confent.com). Cancellations after this date will not be refunded.

### Tickets and Payment

- **Digital Hub Fan Ticket:** €199.00 + VAT valid until December 31, 2024
- **Digital Hub Early Bird Ticket:** €299.00 + VAT valid until August 31, 2025
- **Digital Hub Special Package (3 tickets):** €699.00 + VAT valid until August 31, 2025
- **Standard Ticket:** €399.00 + VAT valid until October 31, 2025
- **Virtual Ticket:** €199.00 + VAT valid until November 6, 2025

If Telia Digital Hub does not take place or the format changes (e.g., to virtual), the ticket will be fully or partially refunded (based on the price difference between the virtual and in-person conference ticket at Kultuurikatel), depending on the new format.

### Personal Data Processing
