

Terms and conditions of the marketing campaign "Campaign for the replacement to the Supreme plan for the customer of the Family plan"

Telia Eesti AS (hereinafter referred to as **Telia**) is organising a marketing campaign "**Campaign for the replacement to the Supreme plan for Family plan customers**" (hereinafter referred to as the **Campaign**) from **11.05.2026 to 17.08.2026**.

The terms and conditions of the campaign apply to **Telia's private customer** (hereinafter **the Customer**) who has a **Telia TV Family plan** during the Campaign period.

- During the Campaign period, the Customer who meets the Campaign Terms and Conditions has the opportunity to change the Telia TV Family plan **to the Telia TV Supreme plan** and use the discounts valid within the framework of the Campaign on the grounds set out in the Campaign Terms and Conditions.
- During the Campaign period, the following terms and conditions and discounts apply to Customers who have joined the Campaign offer:

Telia TV Supreme plan

The Telia TV Supreme plan has a discounted price of €40.30 per month (price according to the price list €44.73 per month), which corresponds to the monthly fee of the Telia TV Family plan. The discount price is valid **for 6 months** from the month of joining.

Go3 additional service

Within the framework of the campaign, the Customer has the right to choose one Go3 additional service, the monthly fee of which is 100% discount for 6 months. The selection includes:

- **Go3 movie channels** (Viasat Kino Action, Viasat Kino World, Viasat Kino, Go3 Films), price according to the price list €8.13 per month – 100% discount;
- **Go3 sports channels** (Go3 Sport 1 and Go3 Sport 2), price according to the price list €10.17 per month – 100% discount.

The discount is applied from the month of joining and is accompanied by a short-term term (the month of joining and the following month).

Play slots

Within the framework of the campaign, it is possible to choose **up to two additional play slots for 6 months with a 100% discount** (price according to the price list €3.10 per month).

- All discounts valid within the framework of the Campaign are valid for 6 months** – – the discount is applied in the month of joining and is valid for the following five months.
- If the Customer has **discounts valid on the Telia TV Family plan**, they will be **interrupted** by joining the Campaign and **will not be transferred to the discounted price of the Telia TV Supreme plan**.
- After the end of the discount period, the **monthly fee according to the price list valid at the end of the discount period** will be applied to Telia's services (the price list may change in the meantime), unless the service has been terminated beforehand.
- Telia has the right to amend or supplement the Campaign Terms and Conditions if necessary, by disclosing the relevant information on Telia's website **www.telia.ee** and at Telia's shops. The amendments shall enter into force as of their publication.
