

Terms and conditions of Telia's campaign "Mobile Life internet plan for new subscribers – 20% for 24 months"

1. During the period 07.04.2026 - 07.06.2026 (hereinafter the Campaign Period), Telia is organising a campaign called "**Mobile Life Internet Plan for New Subscribers – 20% for 24 months**" (hereinafter the Campaign), within the framework of which the customers specified in the Campaign Terms and Conditions can receive a discount of 20% on Mobile Life Internet Plans as follows:

- 1.1. A call plan for each selected number is added at the price of €6.09;

5. In the event of temporary suspension of the service or termination of the provision of the service, including for reasons attributable to the customer, this Campaign Discount will end. If the customer changes the Mobile Life Unlimited + Netflix data volume to another Mobile Life data volume or another plan, the plan change fee according to the price list will also apply.

Terms and Conditions of the Campaign "Discount of €200 on the purchase of a device when joining the Mobile Life at least 8GB plan"

Telia Eesti AS (hereinafter referred to as Telia) is organising a marketing campaign from 01.04.2026 to 07.06.2026 (the Campaign period) with the title "Discount of €200 on the purchase of a device when joining the Mobile Life at least 8GB plan" (Campaign).

1. The campaign offer is valid until the promo codes last.
2. The Campaign is open to a natural person who joins the Mobile Life internet package with a volume of 8 GB or more during the Campaign Period.
3. The discount can also be used if an additional subscription is made to an existing Mobile Life group that is shared with at least 8 GB.
4. The use of the Campaign Offer is accompanied by a **12-month fixed-term obligation** to use the mobile communication plan specified in the Terms and Conditions, and during this period, upon downgrading the Internet volume, changing the package, transferring the number to another customer and terminating the contract prematurely, the compensation according to the Price List (clause 4.1.6.1) will be applied (the balance of the received discount will be compensated).
5. Upon joining the Campaign, the Campaign participant can use a 200 € discount when purchasing a device from Telia in the online store.
6. The campaign participant has the opportunity to choose a device from the following product groups and use a discount code:
 - Smartphones
 - Second-hand smartphones
 - Smartwatches
 - Audio: headphones, speakers, soundbars
 - Game consoles
 - Laptops
 - Recycled laptops
 - Tablets
 - Reused tablets
 - Desktop computers
 - TVs and purchase as follows:
7. The customer can use the discount code in the Telia e-shop and the discount will be deducted from the price of the device, the Telia customer price or the discount price, depending on the price applicable to the devices at the time of realization of the discount.
8. In order to use the discount, a customer who meets the terms and conditions of the Campaign will receive a discount code, which they have the right to redeem within 30 days after the issuing of the discount code. After this period, the discount code will expire.
9. Telia does not satisfy later complaints (in connection with not using the discount).
10. If the discount code has not been used after 30 days from the moment it was issued, the fixed-term obligation will be removed from the mobile phone number and the number for which the fixed-term contract was concluded is again indefinite.
11. If the device to be purchased is more expensive than the discount received, the customer pays the difference between the price of the device and the discount. If the device to be purchased is cheaper than the discount received, Telia will not compensate for the price difference. N: If the customer uses the €200 discount code and buys a €50 device, then upon early termination of the contract, they will have to pay the balance of the discount, which is calculated on the basis of €200, not €50.
12. The discount cannot be summed up, and when buying from an online store, the discount will be deducted from one of the most expensive products in the shopping cart.
13. One discount is valid for one user (mobile phone number), up to 1 discount can be issued per customer.
14. Different promo codes cannot be summed up.
15. Telia has the right to make changes or specifications to the terms and conditions of the Campaign by placing a respective notice in its e-Environment.
